ARCH showed good speed along the rail while in hand, took over and drew away when asked approaching the stretch then widened his margin under a hand ride. CLOUD COVER showed good speed from the outside, set the pace while under pressure from the winner, proved no match for that rival but stayed well to hold the place. IAN'S THUNDER raced along the rail and lacked a rally. EAGLE COUNTY put in a three wide run approaching the stretch but had little left for the drive. ENCRYPTION chased the pace from the outside and tired.
