FOR FILLIES AND MARES THREE YEARS OLD AND UPWARD FOALED IN NEW YORK STATE AND APPROVED BY THE NEW YORK STATE BRED REGISTRY WHICH HAVE NOT WON AN OPEN SWEEPSTAKE AT A MILE OR OVER IN 2005. No nomination fee. A supplemental nomination fee of \$200 may be made at time of entry. \$100 to enter and \$100 to start, with \$65,000 added. The added money and all fees to be divided 60% to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% divided equally among remaining finishers. Three year olds, 120 lbs.; Older 124 lbs. Non-winners of \$35,000 at a mile or over since October 1 allowed 2 lbs.; three races, 4 lbs, two races, 6 lbs.; (Maiden, claiming, starter and restricted allowance races not considered). A presentation will be made to the winning owner. Closed Thursday, August 25, 2005 with 13 Nominations.

JUDY SODA raced in hand early, advanced outside on the second turn, responded when roused, reached the front nearing the eighth pole then dug in gamely and held off SO SWEET A CAT under a drive. SO SWEET A CAT was rated along outside, rallied three wide approaching the stretch and finished gamely outside. SOUTH WING was hustled out to a clear lead, opened a long lead while setting the pace and tired along the inside in the stretch. FAIT ACCOMPLI was outrun early, raced inside and stayed on well in the stretch. MOTHER'S SACRIFICE was outrun early, came wide into the stretch and had no rally. BUNDLE OF ROSES raced inside and had no response when roused.
