ULTIMATE EMPIRE four wide heading for the end of the homestretch, worked out a tuck near the two path midway around it, contently tracked the leader until the five-sixteenths pole, got urged and angled outward for the stretch, took off in earnest after the pacesetter after getting straightened away, struck the front with an eighth to go and kicked away. SEA TO SKY shot of the starting gate, cleared the field and was guided over towards the rail, cut the pace being rated along on a loosely-contested lead, entered the stretch and got asked for run, got wore down by the top one during the ensuing furlong, held on well enough for the place. GROOMEDFORVICTORY stalked the runner up from the outside and gave way. GAMBLIN FEVER got away last after breaking awkwardly, settled along the two path, unleashed an abbreviated run to cut into the gap racing on the second bend, failed to sustain it, then was reported to have bled. JAMES JINGLE saved ground until the quarter pole while being outrun. PISCESBYMOONLIGHT three wide on the opening bend, folded. ELDER SKATESMAN done after a half, drifted seven wide into the lane.
