SOUTHBEACHSANDY came away alertly then moved clear, was challenged near the five-eighths pole, contested the pace on the outside, was asked outside the quarter-pole, dueled with GROUND FORCE in upper stretch, inched clear into the final furlong and proved best under left hand urging. GROUND FORCE moved up near the five-eighths pole, disputed the pace on the inside, was asked outside the quarter-pole, battled with the winner in upper stretch and was outfinished while clear for the place. WEE FREUDIAN threw his head just prior to the break and broke about two lengths behind the field, moved up on the outside, was hard ridden while three then four wide on the turn and lacked the needed response while able to secure the show. JUPITER TRIO settled off the pace, was urged some while two then three wide on the turn, came under a drive in upper stretch and failed to rally. RIZZI'S COMET was reserved off the pace, came under some urging while two then three wide on the turn, swung five wide into the stretch and failed to threaten. CREA'S LAW broke a bit awkwardly, chased the pace, raced two to three wide on the turn, moved out in upper stretch and tired. ELDER SKATESMAN dropped well behind the field, raced near the inside on the turn and never reached contention. DIAMOND SHOWCASE raced well back in the field, went three then four wide on the turn, moved to five wide outside the quarter-pole, floated six wide into the stretch and was no factor. UNCLE SMOKEY moved up under urging outside the half-mile pole, saved ground on the turn and came up empty. PAPA'S NICE CAT was urged along while just off the pace on the outside, chased three to four wide on the turn and weakened. Following the race, the rider of GROUND FORCE lodged an objection against the winner for interference in the stretch. After the stewards' review, the objection was not allowed.
