SHAHZADI lightly urged to the front, was rated on the lead while racing towards the inside, was put to a strong drive approaching the quarter pole, spurted away from her lone serious threat during the ensuing furlong then held sway while kept to strong handling to the end. ABOVE THE CALL urged prompting the winner throughout, proved no match during the stretch drive, but held well enough to be well clear of the others for the place. SISTER BERTA raced along the outside, moved three wide to clear a fading rival just past the half mile pole, then displayed a mild rally to be along for the show. LADY ALMA three wide, was urged on the turn and tired. BIRD IN HAND attempted to reach a good striking position with a four wide run around the bend to no avail. GUILTY CHOICE saved ground and faltered. JILLI'S JOY was through after a half. SHUTTLE CRAFT was off slowly after getting away awkwardly, followed SISTER BERTA, latched on to her hind quarters, from the four path, circling by a fading foe on the turn, had little left to offer during the stretch drive. GLANCE MY WAY retreated to the back of the pack after appearing choppy-gaited on the turn, was eased into the lane, subsequently pulled up and walked off the track.
