**Footnotes**

BABS MOOSSA was outrun in the early stages, came two wide to the stretch while beginning to rally, shifted out at the three sixteenths to avoid the fallen horse, then continued to his rally to come through inside FRUMIOUS in the deep stretch and pulled clear driving. TURBO CALL tracked the dueling leaders from the outset three wide, responded in the drive to get to terms with FRUMIOUS late but could not stall the winner. FRUMIOUS alternated on the lead outside CROSS FIRE into the lane, took a clear advantage when that rival hit the rail at the three sixteenths but shortened stride in the final furlong. PROJECT FIFTY FIVE was void of early speed, raced outside to the stretch and came on without being a factor. PEACE OF ME settled early then saved ground to no avail. TAIPEI DRAGON was always outrun. CROSS FIRE broke alertly and crossed abruptly to the rail while dueling with FROUMIOUS, alternated with that rival into the stretch, then ducked in sharply at the three sixteenths pole and fell over the inside rail. The stewards posted the inquiry and reviewed the incident at the three sixteenths pole but ruled that CROSS FIRE caused his own problems and allowed the original finish to stand.
