Weight 120 lbs. Winners of \$75,000 at one mile or over to carry 2 lbs. additional. Non-winners of such a race of \$50,000 allowed 3 lbs.; of \$30,000 at any distance, 5 lbs.; of \$15,000, 8 lbs. (Trophy will be presented to the winning owner.)

Footnotes

LORIE DARLIN moved into the first turn from the rail, was bumped twice entering the turn, squeezed through to set the pace from the inside and drew off in the stretch while kept to urging. NORTH LAKE JANE exchanged several bumps with NANCYBDANCING leaving the gate, settled in off the rail, came four wide into the stretch and rallied for the place but was no danger to the top one. ZAKALACHEE steadied when squeezed back entering the first turn, saved ground in the early going, found room to slip through inside entering the stretch and loomed a threat but could not go with the winner and lost the place late. OUR SPECIAL ANGEL lacked early speed, started to rally along the rail in the stretch, checked lacking room then had no winning bid. UPON A THRON lugged in on the first turn bothering rivals, saved ground and weakened. NANCYBDANCING traded several bumps with NORTH LAKE JANE after the break and was always outrun. OUR PLEASURE JET was never close. ENDLESSLY pressed the pace of the winner from the outside and tired. THERE WERE STEWARDS' INQUIRIES INTO THE START AND THE RUNNING ENTERING THE FIRST TURN BUT NO ACTION WAS TAKEN.
