**Footnotes**

FADE TO GOLD hopped at the break and was off a bit slow, raced unhurried from the inside early, commenced her bid from the two path on the second turn, cut inside RIVER SLANEY in the stretch, gained command past the furlong pole and drew clear driving. BROUGHT TO JUSTICE was void of any early speed while racing on the rail to the backstretch, began to rally from off the rail on the second turn, angled to the outside for the stretch and closed willingly. SOUL PATCH stalked the pace two and three wide to the stretch but lacked a closing response. RIVER SLANEY dueled inside SUETOSUETOSUE to the stretch and weakened. SUETOSUETOSUE dueled outside RIVER SLANEY for six furlongs and came up empty. AUNT BESSIE stalked the pace from off the rail early, dropped inside for the second turn but had no response.
