### Footnotes

CHARM DOLL chased the leaders to the turn, rallied three wide and pushed to the front in upper stretch then held under steady urging. BOLD LASSIE dueled outside of TRIBAL LADY to the turn, responded when challenged by the winner to the stretch, was outrun to mid stretch but stayed on late and was second best. HOUSE OF CRYSTAL was outrun to the turn, rallied four wide to the stretch then made steady progress in the lane. LUVOLE' had no speed, was three wide to the stretch and was gaining in the final furlong. WARREN'S COLLECTOR chased the pace three wide to the stretch but lacked the needed late response. VIVA LA BEAU dwelt in the gate at the beginning then was hustled after breaking, raced well back to the turn, was three wide to the stretch then showed some late interest. CARTIER BIJOUX stumbled at the start, recovered and chased the the pace while saving ground to the stretch but weakened in the final furlong. TRIBAL LADY was hustled, had speed to the middle of the turn then gave way to the stretch and stopped through the drive.
