FAVORITE TIMES had good speed and duelled for the lead to the turn, responded to the stretch, drifted out and brushed STRIKING COBRA in mid stretch then slipped clear while continuing to drift to the wire. STRIKING COBRA duelled the winner to the stretch, responded once in the lane, was brushed and carried out slightly to mid stretch then continued to drift out on her own and weakened. DANZIANA prompted the pace early, had no room and had to wait for room to the turn, shifted off the rail and began a rally but bore out into the stretch then was no match for the winner. MARLA BAY stalked the leaders but was also caught with no room down the backstretch, raced in hand to the turn, dropped back slightly then came two wide to the stretch but finished evenly late. BETTOR KNOT also was in a stalking position to the turn, came three wide and attempted to rally then had her path taken and was carried seven wide into the stretch and lacked a closing response. A steward's inquiry into the incident involving DANZIANA and BETTOR KNOT into the stretch resulted in the disqualification of DANZIANA from third to last.
