VINDICTIVE CAT was unhurried while in contention to the second turn, bid three wide to the stretch, eased out for room in upper stretch then closed determinedly and made a late surge to grab the win. WALTZING SWAN was also unhurried, saved ground to the stretch then responded between rivals in mid stretch, pushed to the front in deep stretch but was nailed by the winner. MEAN JOLEENE tracked the pace to the half, rallied two wide to the stretch then closed steadily but was outfinished. CHARS PROBLEM attended the pace outside of ADVANCE TICKET to the second turn, responded to pressure and took a short lead to mid stretch but weakened in the late stages. NIPSYS REAL JOY stalked the pace to the half, came three wide to the stretch, dueled to mid stretch then also weakened. BIMERANG was allowed to settle, advanced inside on the second turn but lost her punch in the final furlong. DA HEAT settled mid pack for a half mile, moved three wide on the second turn then swung out widest in upper stretch but could not make an impact when clear. ADVANCE TICKET contested the pace from the rail for six furlongs but tired in the drive.
