### Footnotes

OUR NAUTIQUE (NZ) broke out, bumped ROOSTER CITY then bobbled, recovered and stalked the leader to the half mile pole, bid inside LAMA CHANT on the second turn, pushed to the front when roused into the stretch then held under steady urging. BOLD CHIEFTAIN was allowed to settle three wide to the backstretch, bid three then four wide on the second turn, could not catch the winner but finished steadily to hold second. WHATSTHESCRIPT (IRE) was unhurried early, bid inside into the second turn, shifted two wide into the stretch then was outfinished in the final furlong. DUNMORE EAST chased the pace to the half, was two wide to the stretch then could not muster the needed late response. DEACON SPEAKIN' was outrun for six furlongs, raced four wide to the stretch then was making up some ground late. ROOSTER CITY bumped with the winner shortly after the start and was rank to the first turn, stalked the pace two wide to the stretch then gave way. LAMA CHANT contested the pace for five furlongs, continued to respond on the second turn but gave out through the drive.
