SUNNY DAWN set all the pace while off the rail to the stretch, responded when set down for the drive and won under steady urging. LADY'S ADVANTAGE prompted the winner to the second turn, rallied three wide to the stretch then could not make an impact late while saving the place. GO FOR LAUNCH was allowed to settle to the half, made a bid inside on the second turn to reach contention then flattened out late. PERFORMER INFLIGHT saved ground, was asked for speed on the second turn and had a mild late bid. UNTAMED DANCER had no speed, got fanned four wide to the stretch then came on a bit late. SUPERSTITION GIRL tracked the leader two wide to the half, remained two wide to the stretch but finished evenly. COLDBEERATHEBIT got fanned four wide to the backstretch, settled to the half, came three wide to the stretch but weakened in the drive. RED FILM (GB) hesitated and was off slow and was outrun. QUEENOFTHEBALLET was allowed to settle for a half then had nothing to offer when asked.
