DANCEFORJONESZIE forced the early pace from between rivals, rallied to duel into the stretch then surged clear. R LA PATRONA set the early pace from along the inside, dueled into the stretch, yielded in the drive but held the place. QUEEN OF BRACKEN was unhurried early, went five wide placing a bid and gained the show. ENCANTADA prompted the early pace angling in to save some ground four wide and lacked a closing response. GHOSTLY BREW was allowed to settle early racing off the rail, angled four wide and lacked a gain late. SHOULD was outrun early, went five wide and lacked a rally. APPEALTOHEMINISTR failed to threaten. MOTEL CHAIN showed little in a dull effort.
