MR. PINDTER (MEX) was outrun early, gained steadily, circled the field into the second turn, closed with a rush and prevailed. SQUARE DEAL dueled into the first turn on the outside, edged clear down the backstretch, held the advantage to nearing the wire and was denied by closing rival. DEVOUR stalked the early leaders racing off the rail, vied nearing the eighth pole angling in along the rail and gained the show. INVADER'S JUSTICE was unhurried early, angled four wide in the stretch and showed some interest late. EMPIRE HOUSE showed brief speed along the inside then tired and gave way. TAKIN ISSUE made a move mid way four wide then faded. BOOGER BOO trailed the field and was always outrun.
