### Footnotes

TRACK RANSOM dueled for the lead with CAT SIMON all the way, held on at the wire with a driving finish. CAT SIMON dueled lead all the way, fought gamely down the lane and just got edged at the wire. DIXIELAND CHIME was in the middle of the pack, closed fastest up the rail to get up for show. DEVIL ACTION chased the pace going four wide, then rallied at the eighth pole. HATTIE'S MEMORY had no early speed with an inside trip and a mild bid down the stretch. RETSINA SPRING stalked the pace going two wide, angled out at the sixteenth pole and dropped back. MANOLITO was mid pack going four wide with no bid. PAULS HEART got off slow with no late run. QUICKLY had no early foot and showed little.
