MISS BULLETTE dueled on the outside of rivals from start, went gamely in drive only to be outnodded in the end. WORTH A POT FULL was allowed to settle early, came four wide when making bid into stretch, finished with a belated mid track rally. DAWN TERA duel while between rivals to stretch, tired. BEV'S FAST LANE well positioned entering stretch, had no rally. KATIE'S PROSPECT was not a factor. A PENNY LANE never threatened. CUTIE MILLER was outrun.
