ST PATRICKS APPEAL chased early pace, responded to take over at the half, kept to mild urging throughout stretch drive while holding safe margin to wire. EVANSVILLE VAN stalked leader for half, moved ;up to challenge leader in stretch, no match in drive but clearly best of others. MEDICINE CREEK well back into stretch, finished with a mild rally to gain show spot. PURSUXIT was never a threat. STARRY STRIVE was always outrun. HECTOR hustled to front, set pace for quarte3r mile, stopped after half.
