DENAESALILDEVIL had good speed and dueled for the lead outside of RUN RIGHT THRU to the stretch, responded to get away to mid stretch and widened under steady urging. RUN RIGHT THRU broke in a tangle but was rushed up to engage for the lead, dueled inside to the stretch, could not match strides with the winner then was tiring late and just saved second by a nostril. LUCERA (IRE) was outrun to the turn, tried to rally but was fanned four wide to the stretch then found her best stride and was closing with gusto. DON'T BLINK TWICE had no speed, was outside of LUCERA (IRE) and forced five wide to the stretch but also finished in a rally. JUST A TWITT had no speed, made a bid inside on the turn then lugged out into the stretch and came up empty. GAYLE'S GALA had no speed, raced three wide to the stretch and did not rally. FIVE STAR CAT was hustled but outsprinted, stalked the pace to the turn then gave out. SHE'S ALL FIRED UP trailed throughout.
