HAAS'N ALIBI broke in stride and dueled outside PENA early, drew clear once on the turn, maintained the advantage to mid stretch then just did last. KILKENNY CREEK tracked the winner from the inside into the lane, shifted outside that rival near the sixteenth pole and closed well from between horses. SKATTLE BAND lacked good early speed, moved up four wide on the turn, loomed a bold factor a furlong out but lost some of his punch in the final stages. PINK MENACE (MEX) raced unhurried early, came three wide to the stretch and lacked the needed rally. CHEROKEE OUTING was forwardly placed from off the rail but slackened in the final furlong. FLOR DE RANDI was void of early speed, got fanned five wide on the turn and lacked a rally. BUY BACK STAR saved ground to no avail. VERMONT'S SUZIE Q had no speed and was eased in the stretch but walked off. PENA ran off prior to loading into the gate but was caught and returned, then showed good speed to the turn but stopped suddenly and was eased in the stretch but walked off.
