CANDY JO broke in a tangle but recovered quickly and pressed the pace to the turn, rallied three wide to the stretch then responded to strong pressure in the lane and closed with a late surge to be up in time. SNOWDROP set the pace to the turn, met a bid from DEVONS SMOKIN into the stretch, inched away again under urging then stubbornly held on to deep stretch before losing the nod. DEVONS SMOKIN prompted the pace to the turn, rallied inside of SNOWDROP and drew alongside that one into the stretch but could not maintain the needed response. RIVER SONG was outrun to the turn, raced two then three wide to the stretch and made a bit of progress late. STAR QUALITY was allowed to settle to the turn, saved ground to the stretch but came up empty in the drive. HUNTER'S FORTUNE tracked the leaders to the turn, was caught three or four wide to the stretch and did not have a response when roused. I APOLOGIZE broke a step slow and was outrun. ANGELS AWAITING was not a factor.
