SMOKESTER HORIZON rail, dueled, drew clear upper stretch, ridden out. CALFORMECALIFORNIA between horses, evenly, rallied 4 wide stretch, gaining. FROSTY REMARK rail, evenly, rallied 3 wide upper stretch, finished well. SCOOTER BOOTS slow early, outside, gaining 2nd turn, rallied stretch, gaining. DEPUTY WILD CHILD dueled, outside, weakened 1/4 pole, dropped back. NINDAWAYMA rail, chased, weakened 1/4 pole, faded stretch. LOT A SMOKE close up, evenly, weakened 2nd turn, dropped back stretch. ISABEL'S PRIDE 3 wide first turn, trailed.
