UNO ROYALE took control two wide, repulsed rival into lane, drove clear. SHE WALKS ON AIR moved outside leader into backstretch, loomed into lane, game. NEW DAY RISING four wide into first turn, moved inside into lane, bested rest. HYMN FOR HER steadied bit early, bid outside into far turn, tired. CANDY FOR EDDA settled two wide, chased to far turn, tired. BUCINE outrun inside early, never reached contention, tired. CBT FRENCHMISTRESS three wide early, moved inside soon after, tired. RASPBERRY GIRL chased three wide early, no menacing speed, tired.
