UNO ROYALE up close inside leader, angled outside that one, ridden out. CREME DE LA CAT hustled to command, no match for winner, held place gamely. LARISSA'S DREAM chased inside, no menacing response into lane, faded. DODI N ME chased outside, two wide into lane, no impact. DEWAMERE chased inside, angled out into stretch, no response. CAPPUNCH chased two wide, no response on turn, tired. ACT WON chased two wide turn, gave way into lane, tired. CASHMERE KELLY brief speed two wide, four wide off turn, tired.
