SEASIDE SLEW pressed the pace while saving ground and couldn't stay with the winner. NATIVIUS stalked the pace to the stretch and tired. COP COOKIE was outrun. MAKEITORBREAKIT quickly took command, held a short lead for a half, dueled between rivals to the quarter pole and was used up. J. W.'S CRYSTAL was entangled at the start and was declared a non-starter.
