QUAD'S DOUBLE quickly clear, set pace on or near rail, strong drive. LONG HILL GLIDER saved ground chasing, closed well for place, second best. SHARP AFFAIR up close inside, two wide bid along turn, weakened. PROUD LAWMAN moved inside early, saved ground throughout, no impact. TOMS FIRST COYOTE outrun outside, wide leaving turn, faded. EVIL BUDDHA up close two wide, three wide into stretch, tired. MOUNT NEBO chased two wide early, along rail into lane, tired. TEXAS MIKE chased two-three wide, no response, tired.
