SOLICITUDE moved inside into the first turn, race up close and was covered up at the rail into the far turn, made a two wide move into upper stretch and drew clear under steady urging. DR MAUREEN H broke to command to be clear early, was put to rating from the two path entering the first turn, set the pace to upper stretch, yielded to the winner inside the final sixteenth and continued game for the place. LIL NATE'S DATE steadied in tight into the first turn, loomed two wide into the far turn, angled three wide into the lane, closed well outside leaders in mid-stretch then was outfinished for the place. MAKEITORBREAKIT chased two-three wide to far turn, moved to rail into lane, faded. MY SATURDAY GIRL settled off inside early, asked for response far turn, tired. ELEGANCE GIRL off very slow, chased from inside throughout, no bid, stopped. Following an inquiry into the action into the first turn and an objection by the rider of LIL NATE'S DATE against the rider of SOLICITUDE for alleged interference, the stewards determined that the rider of DR MAUREEN H came inward and was responsible for causing crowding entering the first turn and was disqualified from 2ND and placed 3RD.
