Footnotes

CHENIA settled inside and unhurried for a half, eased out three wide advancing into the lane then steadily closed while racing furthest out and was along in time. YINGYINGYING was unhurried two wide, moved up four abreast along the backstretch and four wide along the far turn, led late but was caught in the final strides. CASA NEKIA, three wide early and forwardly place throughout continued with a game finish and finished in a dead heat for the show position. LADY BEELZEBUB was hustled to command and raced along the hedge throughout and was narrowly outfinished late. ARVILLA PRISCILLA stalked from the inside, was two wide into the far turn and then was blocked briefly while inside leaving the far bend losing some momentum then had room along the rail through the lane but needed more. PARISIAN AFFAIR never too far back, three wide stalking, no late punch. VOLATILE VICKIE well placed inside early, steadied racing into the far turn then continued with a game finish. SPARKLE N GOLD chased four wide early, loomed three wide far turn, faded. STRAWBERRY LINE settled inside, eased out far turn, four path into lane, faded.
