CONRAD CROSSING moved up three wide early stalking the pace, moved two wide with a bid off the far turn, wore down inside rival late and edged clear. BEAN raced up close two wide, chased the from inside into the far turn then closed late outside to gain the place. INVITE DISCO CINDO was sent clear soon after the break, battled inside to deep stretch then faded and lost the place late. DJINN SLIPPERS was unhurried inside, moved out wide off the far turn then finished willingly. JUDGE KELLY settled inside, moved out three wide into the stretch then had a belated bid. HERE'S YA SOUVENIR in contention two wide, steadied on the rail into the stretch then had no late punch. COUNTY ROSCOMMON four wide into first turn, moved inside into far turn, no menace. BLUE ORAGE chased three wide early, two wide into far turn, tired. MIDSHIP MAMBO in contention inside, bid two wide far turn, tired. GONNA BLOW up close four wide into backstretch, no response, tired.
