FROSTLY KNIGHT in contention outside, five wide turn, wore down leader, all out. GLENWOOD ACE contested pace two wide, narrow lead into lane, grudgingly late. SIR CLASSIC CHRIS chased outside along turn, five wide off turn, closed well late. HARVICK chased three wide turn, bid into stretch, outfinished late. DR. FIELD chased two-three wide turn, no serious bid, needed more. WEST TEXAS close up inside, factor to mid-stretch, weakened. ENERGY CENTER in contention three wide, drifted bit into stretch, weakened. FIRST IN ORDER forwardly placed three wide, no response off turn, weakened. CREVE COEUR chased outside, five wide or five path, weakened. SQUIRE PHILIP brief speed four wide, no response off turn, tired. TOUCH A PRINCE outrun along inside, no menacing speed, tired. EL QUIXOTE hustled clear early, gained inside, gave way, empty.
