SCORPION STRIKE stumbled at the break, went three wide to gain the early lead, drew off into upper stretch then was kept alert to the wire. SLICK VIC disputed the early pace inside, yielded to the winner into the lane then continued evenly through the stretch. ANGEL OF THE HOUSE attended the pace two wide early, was three wide along the final turn, weakened. OWEN MEANY settled inside, angled outside leaving far turn, evenly no bid. MACHO MUCHACHO settled two wide early, never menaced leaders, no impact. ROBBIE'S EXPRESS settled inside early, moved outside off final turn, faded.
