PRESENTLY quickly dueled clear early stages, set the pace along the inside then was kept to strong urging to the wire. DEALING LUCKY moved two wide into the turn, rallied into upper stretch and was clearly second best in a game try. TACO DON up close inside winner early, couldn't keep pace, weakened. QUAD'S DOUBLE two wide into turn, wide three wide bid off turn, faded. PLANT CITY RED chased saving ground along turn, no menacing bid, evenly. GOLDEN GATOR off step slow, outrun to turn inside, angled out, belated rally. DUMPSTER DIVER chased three wide into turn, four wide off turn, no menace. GLOWING PROMISE chased three wide along turn, no response into lane, weakened.
