ORIENTAL QUEEN was never far back from the inside, made a two wide move to gain the lead, was ridden out then wrapped up and geared down late. PRAYING FOR PAPERS was in contention from the outside, three wide leaving the turn, gamely for place. A CAT FOR JUDY bobbled at break, quickly in front, pace inside, weakened. VERBETICA saved ground chasing leaders, no serious response, faded. SUGAR N JAVA saved ground along turn, rail run through stretch, evenly. DISTINCTIVE AVA chased outside along turn, no response, tired. J. W.'S CRYSTAL chased two wide along turn, no menacing response, tired.
