ROSA P, up close three wide, move over to be two wide along the turn then gradually wore down his inside rival and held sway under urging. PRINCESS ACCOUNT, forwardly placed early, was steadied while in tight racing into the turn, eased out three wide off the turn then closed game. SHAYE ALONE duelled from the inside into the turn, edged clear into the stretch and weakened late. TERRA KATE disputed the pace from inside rivals, chased into upper stretch and weakened. CINDARULLAH was never far back and saving ground along turn, no late impact. KILLER APP chased three wide, fanned out leaving turn, weakened. TOUGH COOKIE BABY two wide chasing, drifted slightly leaving turn, tired. An objection by the rider of PRINCESS ACCOUNT against the rider of ROSA P for alleged interference entering the turn was not allowed.
