AFRICAN ANGEL vied inside rivals early, repulsed rival through stretch, dug in determinedly final sixteenth an edged away. STORM SLEW forced pace two wide, narrow lead into the stretch, brushed with the winner then faded late. GOLDEN GATOR moved off inside early, wide run into stretch, evenly far outside. HEAVYWEIGHT attended pace three wide early, no response into lane, weakened. MACHO MUCHACHO unhurried early, no menacing speed, outrun. MALKEINU saved ground early, stayed inside along final turn, tired. GET READY GO walked out off the gate and was immediately pulled up, no apparent distress. The Stewards conducted an inquiry into the start concerning GET READ GO. An objection by the ride of STORM SLEW against the winner for alleged interference in the stretch was dismissed.
