GATEWAY WEST settled inside, four wide run into lane, drifted bit through the lane and won driving. SAARCASTICLY moved up two wide into the turn, was five wide into the stretch then continued gamely outside the winner. LIGHTS OF BROADWAY contested pace two wide to turn, clear into lane, faltered. CHIEF OPERATOR off step slow, angled out leaving turn, too late with bid outside. DENNISPORT contested pace three wide, between rivals into turn, weakened. GAMBLER'S HONOUR narrow advantage inside rivals, faded drifting off turn, weakened. NORTHERN LINKAGE forced pace four wide into turn, six wide leaving turn, tired. An objection by the rider of SAARCASTICLY against the winner for alleged interference in the stretch was not allowed.
