(Maiden, Claiming and Starter races not considered in estimating allowances.) Starters to be named through the entry box by the usual time of closing. If this race is not divided it will be limited to 14 starters. \$100 Supplementary Nominations close Friday, October 11. NOMINATIONS CLOSED Monday, September 30, 2002 with TWENTY FOUR (24).

CRESCENT COAST broke inward at the start, stalked from the outside, wore down the leader under a stiff drive and was safe from the runner-up late. FAVORITE ENDING, never far back and three wide, was in the five path into the lane then closed determinedly for the place. YACHT TO PAY FOR was hustled clear to set the pace from the three path around the turn then yielded stubbornly to the top two. VALID MISS CHAIN, unhurried to the turn, was in the four path leaving the turn and continued evenly through the stretch. LUCKY PAWS chased the leader two wide and in the four path around the turn then came up empty in the stretch. ICY FLIRT, in contention inside rivals, gave way in upper stretch and weakened. LOTTA GLITTER, jostled at the start, never seriously menaced while racing the five path leaving the turn. SHORT NOTE was jostled at the start, chased to the turn, was wide leaving the turn and faded. SHE RULES chased inside rivals, gave way into upper stretch and tired. EDEY'S VILLAGE was off a step slow, never seriously involved thereafter.
