Footnotes

SHEMOVES soon had the lead from inside, was just off the inside through the bend, roused upper stretch, lengthened command and was kept to a mild drive until the waning yards. AWINTERSDREAM pressed SHEMOVES from just outside, weaved some while all out in the stretch, was no match for the winner but stayed clear for second. IF I HAD A BULL away slowly, advanced from inside on the bend, floated out behind AWINTERSDREAM into the stretch, took over third and leveled off the final furlong. WILDWOOD BAND in contention between horses on the backstretch, improved position just off the inside on the turn, swung out five wide for the drive and lacked a stretch bid. RUFFY TRICK prominent from outside, took the bend four wide but flattened out through the stretch. COWBOY'S KITTY showed first, gradually backed up from between horses, was three wide on the turn, drifted out to path six entering the lane and steadily faded while allowed to coast.
