DADDY O. was within striking distance early, circled the field looming up to take command at the top of the stretch and opened up late. PREMEDITATED LEGS stalked the early leaders, went five wide at the quarter pole, showed some interest late drifting in nearing the sixteenth pole, gained the place but was no match for the winner. FRANCISCO YULLA set the early pace quickly drawing clear, was challenged nearing the quarter pole, failed to match strides with the winner and yielded. INIQUITOUS KID was unhurried early racing along the inside, sustained a bid then was forced to steady when PREMEDITATED LEGS drifted over into his path, altered outward but was unable to recover. SHINNY SEASON was bumped at the start then dropped back racing wide down the backstretch, angled in thru the turn and placed a mild bid late. H. E.'S FAST was off slow early, went six wide at the quarter pole and lacked a rally. LIGHTNING CANYON forced the early pace from the inside, was used up early and gave way. I B SIX broke outward at the start bumping SHINNY SEASON then retreated steadily. There was a Stewards Inquiry and after reviewing the films PREMEDITATED LEGS was disqualified and placed fifth for interference in the stretch.
