DEE SWEET SPEED steadily lugged in, dq-bothered rival. ROYAL DEUCE AGAIN bumped after start, forced out, drifted out midstretch. CASHY LA JOLLA forced in, dq-bothered rival, checked 70 yard pole, altered out. GO MAGIC DASH bobbled start, angled out late. IM ROYAL QUICK broke in, bumped, checked near 1/16, altered. MSG ON EASY STREET no mishap, closing. WOK OF FAME forced in inside 1/8, checked, altered out. THERMO RYON jostled start, checked, altered in. BLOWS MY MIND jostled start, steadied early behind traffic. IM GREATFUL TOO gradually angled out, no rally. There was a stewards' inquiry into the race. There was also an objection lodged by the rider of WOK OF FAME claiming interference from CASHY LA JOLLA inside the final furlong. There was an objection lodged, as well, by the rider of CASHY LA JOLLA claiming interference from DEE SWEET SPEED deep stretch. After their review, the stewards disqualified CASHY LA JOLLA and placed her seventh. DEE SWEET SPEED was disqualified and placed behind CASHY LA JOLLA, which moved CASHY LA JOLLA up to sixth and DEE SWEET SPEED receiving seventh place earnings.
