C C MANOR was within striking distance early four wide, rallied in the stretch being urged steadily while drifting out and drew clear. APPLELINA was void of early speed, went five wide closing fast but didn't have enough. DANCE WITH TRIXIE was off slow early racing off the rail, angled out in the turn and finished willingly. LIL LAST DANZ set the early pace drawing clear between foes, was challenged, in the stretch and weakened. RYXENA chased the early leader five wide then faded. HENNESSY ROAD was unhurried early five wide and lacked a late response. LA LA LA DANDY was outrun early, went six wide and was not a factor. VIXEN IN MY DREAMS was forwardly placed early saving ground then retreated.
