ON A THIN LINE lugged in midstretch, altered out late, rider lodged objection. SOLILOQUIES pressed, evenly late. SCOOTAN A LIL BIT broke out, chased, no late bid. ROYALTY ON WATCH away slowly, passed tired ones. KITTY D VIL stumbled start, even effort. BUG OUTTA HERE blocked midstretch, no late bid. SEXY N SASSY no speed, taken up inside 1/8. After the stewards' review, the objection lodged by the rider of ON A THIN LINE was not upheld.
