MY OTHER MEMO was unhurried early, went six wide closing the gap, sustained a bid to duel in deep stretch, then surged clear nearing the wire. GAMBLING MISTER was allowed to settle early racing off the inside, angled three wide to rally in the stretch, duelled briefly and failed to match strides with the winner. MILEAGE was forwardly placed early saving ground, shuffled back in the turn then angled three wide and finished well enough to get up for the show. CRISPY COREY prompted the early pace four wide, gained a short lead at the quarter pole then flattened in the drive. GOLDEN COUNTY forced the early pace from the outside, was finished after a half then weakened. PUP was slow early racing well off the rail and placed a mild bid. PERKINSVILLE was within striking distance early, went six wide and lacked a late effort. KALYRA CAT raced off the inside and improved his position in the stretch. CLAUDE H failed to threaten. NATHAN'S SPECIAL was outrun racing off the rail and was not a factor. GRAND DECREE showed some brief speed racing off the inside, then retreated steadily and stopped.
