PLEA AGREEMENT raced off the pace inside, bid three wide passing the quarter pole and drew clear under urging. R EL JEFE settled off the rail, came three wide into the lane and rallied outside for second. GRAND SLAM ANDRE chased outside, came three wide into the lane and lacked a winning bid. WESTERN PINE dueled inside and weakened. MATTO MONDO (CHI) dueled outside and tired. REMUS saved ground and did not factor. SHORT MEMO chased and faded. After a Stewards' Inquiry into the stretch run, the race was declared official.
