Footnotes

LUNCH BOX pressed the early speed from inside, squeezed through along the rail midstretch and took the advantage seventy yards out. HE'S MY DESSERT tried to duck in leaving the chute, was checked, hustled up between horses to vie for the lead three wide on the turn, did not keep up at the head of the lane, was all out the last eighth, closed and caught MR. GOLDEN RULER for third. MR. GOLDEN RULER showed first, set a pressured pace between rivals, was two wide on the turn, battled through the stretch but did not have enough left in the waning yards. LAST MINUTE JOE rated from outside, lost ground five wide into the turn, circled horses, angled in some for the stretch run, closed well but was too late. PRINCE CHARMING in contention between rivals on the backstretch, failed to keep up three wide on the turn, lost ground fanning widest leaving the bend and found best stride belatedly inside the last eighth. RUNNIN ONASUGARHI in contention, though at the back, early, angled in some on the turn, swung four wide for the stretch run and also found best stride too late. FAST DEVON displayed early speed between horses but faded two wide on the bend. SHAKIN N DANCIN was prominent toward the outside, gave way four wide on the turn, was unresponsive upper stretch, eased the last eighth and walked off.
