Footnotes

ZEE BEST HENNYSEE was unhurried early, went five wide into the stretch, rallied on the outside, closed fast with urging and was best late. BARBS LETTER tracked the early leaders along the inside, sustained a bid in deep stretch, was gaining late when bumped nearing the wire and battled hard for the place. BLAZING SUPERSTAR set the early pace drawing quickly clear, held to deep stretch, drifted out nearing the sixteenth pole then drifted in nearing the wire and bumped a foe while tiring. ABO TRICK was within striking distance early racing off the inside and closed willingly. SALTY LANE broke poorly, went six wide early, vied into the stretch between, split foes mid stretch then altered in and was gaining. GONE PACK N dropped back early and showed some interest late six wide. HUNTIN A HALO was void of early speed five wide, drifted out in the stretch and closed late. NITRO BUD stalked the early leaders four wide then weakened in the drive. RISE TO DEVON prompted the early pace racing off the inside, began to make a move nearing the wire, was forced to steady when rival drifted in and yielded in the final strides, was vanned off after pulling up. GOLDEN FALCON faded steadily. AINT HE A SCOOTER was forwardly placed early five wide then retreated. TEA TIME WARRIOR failed to threaten. There was a Stewards Inquiry and after reviewing the films BLAZING SUPERSTAR was disqualified and placed ninth for interference in the stretch.
