SILCA SHEETS tracked inside, rallied three wide past the quarter pole and drew clear late, driving. RATE RIDGE vied two wide, gained a short lead and was no match for the winner. GHOSTLY MOVER stalked outside, rallied four wide approaching the stretch and needed more. CAHILL saved ground and rallied mildly inside. SLEWPERMAN saved ground and did not factor. MY SONG OF HOPE vied inside and tired. DON JULIO steadied at the start, rushed up three wide into contention, gave way and stopped.
