RIBALD was within striking distance early racing five wide, sustained a bid nearing the five sixteenth, responded well when asked and kicked clear. DUCKY DRAKE was well back early, went four wide closing the gap then made a late surge in deep stretch to get up for the place. A PLUS TOPPER prompted the early pace, went between foes three wide then flattened in the drive. INTHENICKOFTIME set the early pace saving ground while drawing clear, was challenged into the stretch, came up empty then faded in the lane. STEPHENGOTHISSTAR was well back early saving ground and was not a threat.
