MOCHA BEAN was unhurried early, swung five wide at the top of the stretch, closed fast late and drew clear. DANCERS SISTER set a pressure early pace, gained a clear advantage at the eighth pole and failed to last. COPE'S ANGEL raced mid pack, went four wide in the stretch and showed some effort late. COMICAL KARON was outrun early, closed the gap into the stretch racing the widest and was gaining late. PRETTY LUCKY was allowed to settle early and showed some interest along the inside late. COPELAN'S APPEAL pressed the early pace between rivals then weakened. ON TO THERE forced the early pace from the inside, made a brief bid mid way then faded. BAY OLIVIA showed little and was not a factor. WINDY STORM'N ROSE was hustled away between rivals, then dropped back after a quarter and retreated.
