BANK ON RYON checked repeatedly. STRAIGHT AND QUICK hit gate. SLR LEAVIN LAUGHING no rally. The jockey of BANK ON RYON claimed foul against RABBITS JET alleging interference in deep stretch when the latter lugged out, forcing the former to take up. After a review the stewards ruled insufficient evidence.
